Dr. Rouse's Course Description:

This unique presentation will focus on preventing disease rather than restoring morphology. Restoration of the teeth rarely fixes the core cause of the problem. A growing body of research is beginning to link nocturnal airway issues in adults and children to tooth wear, myofacial pain, craniofacial deficits, periodontal disease and malocclusion. This evidence-based course will provide clinicians with the foundation to differentiate between the categories of sleep disordered breathing and diagnose the variations from oral signs and symptoms. The goal is to prevent rather than maintain a damaged system. Therefore, pediatric evaluation and intervention will play a major role in the day. Dr. Rouse will conclude with a distinctive Seattle Protocol that allows the patient to assist in the creation of a plan of resolution for their breathing issues. **6 Hours CE Credits, Category B**

Jeffrey S. Rouse, D.D.S. maintains a private practice in San Antonio, Texas and practices with Drs. Gregg Kinzer and Frank Spear in Seattle, Washington. He is also an Adjunct Assistant Professor in the Department of Prosthodontics at the University of Texas Health Science Center at San

Antonio and a Resident Faculty member at the Spear Education Center in Scottsdale, Arizona. After graduation from dental school in San Antonio, Dr Rouse completed a 2-year General Practice Residency at the University of Connecticut Health Science Center. He practiced family dentistry for twelve years before returning to school. Dr. Rouse received his specialty certificate in Prosthodontics from the University of Texas Health Science Center at San Antonio in 2004. He is a member of the American Academy of Restorative Dentistry, the American College of Prosthodontists, and past president of the Southwest Academy of Restorative Dentistry. Dr. Rouse has written numerous journal articles including a portion of the "Annual Review of Selected Dental Literature" published each



summer in the Journal of Prosthetic Dentistry. He has a textbook published in 2016 by Quintessence titled "Global" Diagnosis: A New Vision of Dental Diagnosis and Treatment Planning written with his teaching partner, Dr. Bill Robbins. Furthermore, he has contributed chapters on porcelain veneers and anterior ceramic crowns to three editions of a dental textbook. Dr. Rouse lectures nationally and internationally on a wide variety of topics ranging from dental topics ranging from dental esthetics to airway prosthodontics.
