

ASSIGNMENT OF BENEFITS AGREEMENT

As a special help to our patients, LITTLE FISH DENTAL will be pleased to accept an assignment of benefits from you insurance company with the provisions listed and agreed to below.

COST OF TREATMENT

Before treatment you will have benefited from our estimating your costs of treatment based on your insurance company's usual and customary fees. This will reflect the total cost of treatments with our amount credited for insurance coverage [which MAY be paid, but is NOT] guaranteed by your insurance company.

CLAIM PERIOD 30-60 DAYS

Of course we cannot guarantee any payment by your insurance company. However, insurance payments are generally received within 30-60 days from the time a claim is submitted. If your insurance company has NOT made a payment to LITTLE FISH DENTAL within 60 days from filing your claim; please be prepared to pay the amount still due for treatments, and contact your insurance company.

PAYMENTS MADE BY YOUR INSURANCE COMPANY

Even though the contract for insurance benefits is between you, your employer (if any) and your insurance company you will be able to authorize payment directly to LITTLE FISH DENTAL as an assignment of benefits. Any amount paid, will be credited to your account with LITTLE FISH DENTAL. As a help to you we will contact you immediately if any payment from insurance leaves you with a balance due amount. Should your insurance company send to you (in error) the reimbursement check for your processed claim, we will notify you by mail and allow you 10 calendar days to send the full amount of the reimbursement to our office.

YOUR FINANCIAL OBLIGATION

If, after we have helped you to submit your insurance claim; and there remains any payments due for treatment already delivered it will be your obligation to pay any remaining balance in full (within 30 days), prior to the continuing dental care.

PAYMENT FOR TREATMENTS WHICH EXCEED ANNUAL COVERAGE LIMITS

Unfortunately, LITTLE FISH DENTAL cannot monitor the amount of payments your insurance company makes for you each year. Your completed dental treatments may require additional charges for treatments in excess of the yearly maximum for all dental benefits provided to you by your insurance company. Please take this opportunity to familiarize yourself with the total maximum benefits you can expect annually.
